Does your comment relate to the renaming of marine parks? No Please type your comments below: I would like to firstly congratulate Marine Parks for sorting through a lot of strong views to develop the proposed position in your draft plan. I know that a lot of very highly funded overseas "green" groups have tried, and continue to try, to use their wealth and power to change the outcome however it is pleasing to see that the views of normal mum and dad recreational fishers have been taken into account.

My comments relate particularly to the Marine National Park at the Perth Canyon ("the trench" as it is known to locals) an area I am very passionate about. I have fished the trench for over 30 years with my dad, sister, wife, in-laws, brother and guests from overseas and interstate. I would say I spend more time in it that most people responding, so I feel qualified to make comment. The fishing club I belong to, Perth Game Fishing Club, has had older members fishing there since 1949 and I have spoken to some of the longest serving members about past fishing experience and our shared love of the fishing grounds at the Perth Canyon.

Recreational fishers are the most underrated group of marine conservationists. We love and protect our ocean and particularly the fishery at the Perth Canyon. The Perth Canyon is the only area accessible from Perth that allows me the opportunity to catch migratory species such as tuna, dolphin fish and the prizes marlin. Free access to the trench is of the utmost importance for myself, my family and for many other local fishers.

The trench starts at 400m deep and goes up to over 2000m on water depth meaning we have little to no impact with the sea floor or walls of the canyon. As we are generally trolling lures on the surface of the water, my environmental impact is negligible to zero.

I contribute to local businesses by buying marine products, fishing gear, fuel, club memberships and all the other fees and charges associate with boat ownership. The economic benefits of recreational fishers should not be underestimated. With one million plus of us trying desperately to ensure we can have the same access to fishing grounds for our children and their children's children.

I mostly fish tag and release in the Perth Canyon with tagging data supplied to the NSW Fisheries. Fishing the trench allows me to contribute to fisheries research and I would think that a co-operative approach to data sharing can only contribute to better management and future shaping of the marine parks.

I would be more than happy to assist with any citizen science initiatives that would assist in maintaining our access to the trench.

I thank you for taking my opinion into consideration. I will happily assist in any way I can to ensure my access to the Perth Canyon is never taken away
